Ben Eldredge is the At-Large Director for the Cow Creek Groundwater Conservation District, serving the district since 2019. As the Vice President of Conservation at the Cibolo Center for Conservation, Ben has successfully promoted a stream setback increase and distributed stormwater management now required by an award winning Low Impact Development (LID) ordinance. Ben also serves on numerous boards and committees, Hill Country Conservation Network Steering Committee, the Camp Bullis Sentinel Landscaope Core Team, and the Kendall County Greenspaces Bond Committee.
General type of flood-related knowledge, experience, and approximately number of years of
being involved in flood-related issues.
My interest in flood-related issues began in 2010 while serving as a member of the Upper Cibolo Creek Watershed Partnership. While nutrients were an initial concern, it became apparent that stewardship of the uplands, including development that added impervious cover, had a significant impact on nutrient loads, total suspended solids, other water pollution and flood intensity. Since then I have served as an educator for the preservation and thoughtful stewardship of natural infrastructure; including riparian stewardship and restoration, grazing management that facilitates groundwater recharge, as well as sensible development practices that slow water down, filter it and sink it in. In this regard, I take a holisite approach to stormwater management that includes reducing run-off where it begins.
